4 ENROLLED, An Act,

5 Relating to election expenses; to amend Sections
6 17-16-2 and 17-16-4, Code of Alabama 1975, and to add Section
7 17-16-2.1 to the Code of Alabama 1975, to more adequately
8 provide for reimbursement of the county's election expenses
9 and to create an Election Expense Reimbursement Committee to
10 identify other expenses that are eligible for reimbursement.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. Sections 17-16-2 and 17-16-4, Code of
13 Alabama 1975, are amended to read as follows:

14 "§17-16-2.

15 "As used in this chapter, the term "expenses" shall
16 include the following items and any other items approved as
17 reimbursable expenses by the Election Expense Reimbursement
18 Committee pursuant to Section 17-16-2.1:

19 "(1) The compensation and mileage provided by law
20 for election officials.

21 "(2) The compensation provided by law for the clerk
22 or other official acting as absentee election manager.

23 "(3) The costs of ballots, supplies, and other
24 materials or equipment necessary for election officials to

1 conduct elections as required by law and as certified by the
2 judge of probate as chief election official of the county.

3 "(4) The costs of absentee ballots, supplies,
4 postage, and other materials required by law to be furnished
5 to the absentee election manager.

6 "(5) The cost of preparing and furnishing the lists
7 of qualified electors to the election officials as required by
8 law.

9 "(6) The cost of publishing any notice or other item
10 related to any election and required by law, including, but
11 not limited to, the publication of notice of any election and
12 any voter lists.

13 "§17-16-4.

14 "The State of Alabama shall reimburse a county for
15 all sums expended by the county in payment of expenses as
16 provided for in Sections 17-16-2 and 17-16-2.1 and incurred in
17 holding and conducting an election in which only candidates
18 for federal or state offices are nominated or federal or state
19 officials are elected. For the purposes of this section, a
20 candidate for federal or state office includes a candidate
21 seeking election as a district representative for a federal or
22 state office appearing on the ballot in any portion of a
23 county."

24 Section 2. The following new Section 17-16-2.1 is
25 added to Title 17, Code of Alabama 1975, to read as follows:

1 §17-16-2.1.

2 (a) There is hereby established an Election Expense
3 Reimbursement Committee designated to identify any election
4 costs not included in Section 17-16-2, which costs shall be
5 included as a reimbursable election expense under this
6 chapter. The committee shall consist of the following:

7 (1) The President Pro Tempore of the Alabama Senate.

8 (2) The Speaker of the Alabama House of
9 Representatives.

10 (3) The Secretary of State or his or her designee.

11 (4) The Director of Finance or his or her designee.

12 (5) The chair of the Senate Constitution, Campaign
13 Finance, Ethics and Election Committee or its successor
14 committee.

15 (6) The chair of the House Constitution, Campaign
16 and Elections Committee or its successor committee.

17 (7) The chair of the Senate Finance and Taxation
18 General Fund Committee or its successor committee.

19 (8) The chair of the House Ways and Means General
20 Fund Committee or its successor committee.

21 (b) The committee shall meet not less than 90 days
22 prior to the state primary set for June 2012 to develop and
23 approve the list of reimbursable expenses for the upcoming
24 election cycle. After the list has been approved by the
25 committee, it shall be forwarded to the Comptroller's office.

1 The Comptroller shall distribute the list to the chair of each
2 county commission and each probate judge in the state no later
3 than 60 days prior to the date of the primary. The list of
4 approved expenses shall apply in all elections and remain in
5 effect until and unless amended by the committee at least 90
6 days prior to the primary in a subsequent election cycle.

7 Section 3. This act shall become effective
8 immediately following its passage and approval by the
9 Governor, or its otherwise becoming law.
